Spirinolactone and ACE Inhibition in Chronic Renal Failure (February 7, 2002;346:456-7). In the first full paragraph of the right-hand column on page 456, the equation should have read, "mean arterial pressure, calculated as [systolic pressure + (2 × diastolic pressure)] ÷ 3," not "mean blood pressure (calculated as systolic pressure + [0.67 × diastolic pressure])," as printed. We regret the error.

A Comparison of Risperidone and Haloperidol for the Prevention of Relapse in Patients with Schizophrenia (January 3, 2002;346:16-22). On page 19, the sentence that begins on line 1 of the right-hand column should have read, "In post hoc analyses, patients in both the risperidone and haloperidol groups had significant improvement from base line in symptoms after one week of double-blind treatment: the changes in total scores on the Positive and Negative Syndrome Scale were a decrease of 3.9 in the risperidone group (P<0.001) and a decrease of 1.4 in the haloperidol group (P=0.05; P=0.007 for the comparison between the groups)."

Intravascular Gamma Radiation for In-Stent Restenosis in Saphenous-Vein Bypass Grafts (April 18, 2002;346:1194-9). In the table of contents, the title should have read, "Intravascular," not "Vascular," as printed. We regret the error.
